Thank you to everyone that helped keep our players on the field! It may seem early, but due to our League requirements, we need to turn in our player numbers early to plan our 2022 Season. We ask that you let us know your child is playing by completing a sign-up sheet ASAP.

We are excited to have our new Coach, Jason Borders for the 2022 Season. He with some of the familiar faces you know have lots of playing and coaching experience and we pride ourselves on making our players better on and off the field. Powell Legion baseball has expanded its program over the last few years and we now have 3 teams. Jason has some great ideas on how he can bring the skill levels across the three teams and be more in sync with the overall program goals.

We are looking to start practicing in early January 2022, so please make sure you are subscribed to the **NEW Remind group** called **Pioneers PALB 2022**. It is ok if your child is playing another sport at this time. We encourage them to be well rounded athletes. But if they have time or are not playing any other sports, we expect them to show up. This is a critical time to start building arm strength and fine tuning their swings before the long season starts. Practices will be held at Josh Westerhold's indoor facility. Located off of Lane 8H next to the Church of Christ. The indoor facility has 3 bullpen mounds, two batting cages and turf.

Sign-up fee for this year is \$150 per player. This pays for Pioneer apparel and practice fees for the facility. All players will also be required to fundraise for the 2022 season. The Legion Board will provide several opportunities for your player(s) to raise their expected amount. The money that is raised will pay for team insurance, vehicle insurance, hotels, gas, food, umpire fees, tournament fees, and other miscellaneous items throughout the season.

Because we are a volunteer Board and Non-Profit organization, we need your support. We need parent involvement by helping with Concessions and Score Keeping for home games and Tournaments. Coaches, players, parents and the Board are committed to this program. We request that parents help out with the program by holding your child accountable for their fundraising and making practices/games on time. Together, we can make this a competitive and successful program.

In addition, their ruling shall be considered that of an arbitrator to which the parties agree is a final adjudication of all matters in controversy. Procedures for filing an appeal to the National Baseball Appeals Board are outlined in National Rule 10 of the American Legion Baseball Rule Book.. Voluntarily and of my own free will, I elect to participate in the ALB program and as a member of my ALB team.

I understand and acknowledge that the very nature of baseball has hazards that can cause serious injury and/or death. I assume all risks of injury and damage incident to my participation in ALB. I agree in the event of illness or injury during an ALB game or practice, I hereby give consent to the performance of such diagnostic, medical and/or surgical treatment as may be deemed medically necessary to assure my safety.

I have read and understand National Executive Committee Resolution No. 16: Expectations for Rendering Proper Respect when Participating in Programs of The American Legion, October 2016 (copy of which is available at [www.archive.legion.org](http://www.archive.legion.org)) and agree to be bound to the terms of said resolution.

I irrevocably consent to, and authorize the ALB, its licensees, agents, successors and assigns, to use my name, likeness, and voice and to reproduce, distribute, display, and to prepare derivative works of any images or recordings of me taken, or in which I may be included, in conjunction with or without my name, made through any medium, for publicity, advertising, promotional or any other lawful purpose without compensation to me.

I have read ALB's Privacy Policy, Drug and Alcohol Policy, and Fan Conduct Policy (copies of which are available at [www.legion.org/baseball/resources](http://www.legion.org/baseball/resources)) and agree to be bound to the terms of each such policy.

Except as otherwise provided above, I agree that any dispute arising out of this agreement shall be governed by the laws of Indiana, notwithstanding any conflicts of law principles. **Player Role**

1. Respect everyone involved in the program. Yourself, coaches, teammates, opposing teams (their fans), and administration. You are a representative of Powell Pioneer Baseball, and the Powell community.
2. Alcohol and/or drug use of any kind will not be tolerated, and can be ground for immediate dismissal from the team.
3. Hazing/Bullying will not be tolerated at any level, and can be ground for immediate dismissal from the team.
4. Fundraisers are what allow baseball to exist in Powell. All players will take part in fundraising efforts for the program.
5. Have a positive attitude at practice, games and bus rides.
6. Notify coach in advance, if missing a practice or game.
7. Profanity is unacceptable and will not be tolerated.
8. Showcase proper sportsmanship at all times.
9. Inappropriate interaction with officials/umpires is considered unsportsmanlike and will not be tolerated.

***\*Coaches will determine punishment for any absence where the coaching staff was not notified.***

**Parent Support / Role**

1. Promote sportsmanship at all games. Be a positive role model for the Powell Pioneer program. Read #1 above.
2. Not all players will receive equal playing time.
3. Be realistic about your son's/daughter's abilities.
4. Follow the appropriate chain of command for communicating concerns:
  - player communicates with coach*
  - player communicates with parent*
  - parent communicates with coach*
  - parent communicates with board member*
5. If you have a concern to discuss with the coach, please call to schedule an appointment.
6. If you have a concern that needs to be addressed by the Legion Board, please contact a board member and the Board will make the proper arrangements during the next board meeting.
7. Parent involvement/volunteering is essential to running a solid program. There will be times when you are asked to assist with game day activities (scoreboard, gate fees, etc.), as well as the fundraising events held by the Powell Pioneer Program.

**Team Goals**

1. To develop players knowledge and understanding of the game.
2. To develop physical baseball skills to ensure every player reaches their potential.
3. To develop respect towards others by practicing good sportsmanship at all times.
4. To play as a team to reach *OUR* common goal.

**Issues not appropriate to discuss with coaches**

1. Team Lineup
2. Team Strategy
3. Do not attempt to confront a coach before or after a contest or practice. These can be emotional times for both parents and coaches. Meetings of this nature do not promote resolution. *See #5 above under Parent Support.*

**Consequences for Violation of Player/Parent Contract**

1. Warnings will be issued based on the severity of the incident.
2. The majority of the consequences will be dealt with in-house to help promote team unity. Coaches will convene to determine the severity of each offense.
3. Coach and Board of Directors may meet to discuss punishment for each incident.
4. After the first incident, consequences will increase with every offense.
5. Dismissal from the team may be an option; based on repeated offenses and severity of offense.
